## TARGET MARKET

#### DESCRIPTION OF TARGET MARKET

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
  - at least 18 years old;
  - individual borrowers (as single or joint borrowers); and
  - an Australian Citizen that does not reside in Australia, a Permanent or Temporary Resident of Australia with an Acceptable Visa or a New Zealand Citizen that does not reside in Australia or New Zealand;
  - Permanent Resident or Temporary Resident or Citizen of Australia who requires Foreign Income to cover Australian Debt Obligations;



- the visa of an Australian Permanent or Temporary Resident must have a minimum of 6 months validity (155 Visas are excluded); or
- the residential address of the borrower is limited to our "Acceptable Countries" list in accordance with our lending policy;
- require a loan to purchase or refinance residential property as either owner occupiers or investors;
- who may also wish to release some of the equity in their property for investment in property;
- require a loan to build a new home, renovate or demolish and rebuild a residential property as either owner occupiers or investors;
- require an offset account;
- reside in Australia and require an option to attach a Visa Debit Card to their account;
- require the flexibility of a variable interest rate;
- require the ability to make additional extra repayments without penalty;
- require option of interest only repayments for an agreed period of time or principal and interest repayments; or
- satisfy our eligibility criteria.

The financial situation of the Target Market are consumers that meet our credit assessment criteria which includes demonstrating serviceability of the loan, the capacity to make the required repayments and the ability to pay off the loan without substantial hardship. Upon application VCMM will undertake an assessment to determine the consumer's ability to service the loan, which is our process of determining that the product is consistent with the financial situation of the Target Market.

#### **Distribution conditions**

- A material change is made to this product;
- Evidence that the product or distributor conduct are significantly different to the target market; or

• The receipt of a product intervention power order from ASIC requiring us to immediately cease retail product distribution conduct in respect of the product.
